

New Background Check Procedure

We are now using the Family Care Safety Registry!

- This process will include a one-time registration fee of \$10.00 and an additional \$1.00 processing fee. After applicants are registered, they may request a new or updated background check at any time for no additional cost. The Field Experience Office requires that a new Background Check be filed every 6-months for EFE hours and at the beginning of every clinical course. Students will be responsible for requesting and submitting the results to the FEO.
