Move-in Day!

Our two busiest move-in days will feature carside check-in! A move-in day map can be found <u>HERE</u>.

New Students: Wed., August 12th (Car-side check-in)

Returning Students: Sat., August 15th (Car-side check-in) and Sun., August 16th (Hall Desk check-in)

If you haven't already, be sure to sign up for a move-in time slot **HERE!**

Move-in day looks different this year; You'll be able to check in from the comfort of your air-conditioned car! First-year students should've received information about move-in day, including maps and a name placard to put in your car window to speed up the process. Remember: Masks are required in public spaces on campus. (You'll be getting one mask in your check-in packet.) Students may bring two adult helpers to help them move in (no children, please). Once your move-in shift ends, your helpers will need to leave campus.

Important Notes:

<u>Housing Condition Report (HCR):</u> Once in your room, each resident must fill out the HCR that's found in their check-in packet. This is your opportunity to document the condition of the room and is best done before you unpack your things. Please be thorough and detailed in the information you gather and list any damage that exists upon your arrival. When you check out of your room, we will use this information to see if any damage has occurred during your stay.

ID Cards:

If you're in need of an ID card, please visit the <u>temporary home of the ID Office in the Chariton Room</u>, located in Missouri Hall's main lobby. Students should wear masks and socially distance while waiting in line. **BE SURE TO BRING A PHOTO ID WITH YOU**.

COVID-19 Updates

- 1. Have you been around anyone sick or diagnosed with COVID-19?
- 2. Do you have a cough, shortness of breath, or difficulty breathing?

- 3. Do you have a fever or chills?
- 4. Are you fatigued?
- 5. Do you have muscle aches, body aches, or a headache?
- 6. Do you have a sore throat?
- 7. Do you have recent loss of taste or smell?
- 8. Do you have nausea, vomiting, or diarrhea?
- 9. Do you have congestion or a runny nose?
- 10. Have you traveled internationally or on a cruise ship in the past 2 weeks? (We are following the CDC recommendation that you quarantine for 14 days)

If your answer any of these questions is YES, <u>you must consult with a medical professional</u>. It is important for your own well-being that you follow their instructions should you be advised to self-quarantine or self-isolate.
