ITEM H.3 Enrollment Fees

DESCRIPTION AND BACKGROUND

The Higher Education Student Funding Act (HESFA) calculation allows a statutory maximum increase in tuition that is primarily based on the Consumer Price Index (CPI) and it applies to Missouri resident undergraduate full-time students. For FY 2020, CPI was 1.4%. Based upon a 2018 change in statute, if state operating support decreases in a fiscal year, tuition can be increased up to an additional 5%. Because state operating support decreased from FY 2019 to FY 2020, for the 2021-22 Academic Year, the maximum tuition increase allowed under this statute is 6.4%. This is applied to the prior year booked tuition (the tuition rate reported to the Missouri Department of Higher Education and Workforce Development) and allows an increase up to \$488.88 for the academic year for Missouri undergraduates.

It is recommended that the allowable 6.4% increase be applied to resident and non-resident tuition for undergraduates. These new rates will be officially booked with the Missouri Department of Higher Education and Workforce Development. For the current Academic Year (AY 2020-21) the maximum allowed under HESFA was booked, but a portion was waived. A similar process is recommended for 2021-22 with a 4.9% increase applied to the actual base tuition charged for 2020-21 rather than 6.4% being applied to the booked amount for AY 2020-21. The result is an increase of 4.7% for total tuition and required fees for a Missouri undergraduate student, but will leave an additional 4.2% which has been officially booked but not charged. Most four-year institutions are taking this approach to provide a buffer should the CPI be very low in future years.

No changes in designated fees such as the Athletic Fee, Health Fee, or the Student Activity Fee are proposed. The charge for the Freshman Orientation Program is also recommended to remain at the current level. The amount in base tuition designated toward operation of the Student Union is recommended to increase by \$20.00. This increase is needed to partially cover operating costs of the facility. With the proposed increase, tuition and required fees actually charged will increase by \$390 for the academic year for a Missouri resident undergraduate student.

RECOMMENDED ACTION

WHEREAS, Truman State University's permitted increase for Missouri resident undergraduate full-time students for the 2021-22 academic year is 6.4% under the terms of the Higher Education Student Funding Act; and

WHEREAS, it is advisable to book this increase at this time;

NOW, THEREFORE, BE IT RESOLVED that Truman State University will apply this increase on the actual tuition rates for 2020-21 academic year under the terms of the Higher Education Student Funding Act and waive a portion of the additional increase at this time; and

BE IT FURTHER RESOLVED that the following enrollment fees for full-time students be approved, effective with the 2021 Fall Semester:

- 2) Graduate students who are enrolled in standard graduate level programs: Graduate Students............\$400 per credit hour

BE IT FURTHER RESOLVED that the President is authorized to establish additional graduate pricing tiers for specialized and high-cost graduate programs to be competitive with other institutions; and

BE IT FURTHER RESOLVED that the designated fee for the Student Recreation Center included above be maintained at \$222 for each full-time equivalent student per academic year; and

BE IT FURTHER RESOLVED that the designated fee for the Student Union included above be increased to \$220 for each full-time equivalent student per academic year; and

BE IT FURTHER RESOLVED that the following additional enrollment fees for students enrolled in 6 or more semester hours during the academic year be approved as follows:

- 1) A student activity fee of \$90 per academic year (\$45 per semester);
- 2) A student health fee of \$74 per academic year (\$37 per semester);
- 3) An athletic fee of \$116 per academic year (\$58 per semester);
- 4) An information/technology (itech) fee of \$34 per academic year (\$17 per semester); and
- 5) A sustainability fee of \$10 per academic year (\$5 per semester).

BE IT FURTHER RESOLVED that the freshman orientation fee remain at \$350 for freshman students during the fall semester, and a corresponding fee for freshman students participating in comparable orientation programs during other semesters, with each freshman student to pay such an orientation fee only a single time; and

BE IT FURTHER RESOLVED that the President of the University is authorized to charge tuition and fees for 2021-22 as outlined in Table 4 of the attachment; and

BE IT FURTHER RESOLVED that the President of the University is authorized to establish summer school rates designed to enhance enrollment in such programs; and

BE IT FURTHER RESOLVED that the enrollment fees for part-time students, interim sessions, study abroad, professional development, specialized graduate programs, on-line programs, and the other enrollment fees, and miscellaneous charges not listed in this resolution, be established by the President of the University, based on the above fees and charges, in accordance with Section 11.010 and 11.020 of the Code of Policies; and

BE IT FURTHER RESOLVED that a copy of the background information and rationale for this fee proposal be attached to the minutes as an exhibit.

Background Information and Rationale for FY 2022 Enrollment Fee Proposal

Background Information and Rationale for FY 2022 Enrollment Fee Proposal

For several years public institutions in Missouri have held tuition increases at or below the Consumer Price Index (CPI). This is due to the tuition cap statute as well as multiple agreements with the Executive and Legislative branches of government to cap tuition increases at a minimum. Tuition increases have been at or below 1% five times in the past decade. During that same period (FY 11 – FY 20) Truman's state appropriation declined by 15%. Actual state support for FY 2021 is roughly equal to FY 1999.

Several Missouri institutions with different tuition rates for traditional versus online programs have indicated that they plan to blend these into single rates and request a waiver on the tuition cap. Missouri State has already taken this action, and the new rate represents a 12.7% increase per credit hour. Northwest, Central, and Southeast also plan to request waivers for blended rates which will exceed the tuition cap for 2021-22.

Comparisons of total costs including mandatory fees are not available at this time, however Table 1 outlines typical tuition and fees by campus for 2020-21. Truman has maintained its relative position in this list for several years. Table 2 and 3 outline tuition and fees at Truman including the proposed "booked tuition" for 2021-22.

Proposed Actual Tuition Charged for 2021-22

As recommended in the agenda item, the subtotal for tuition, Student Union, and Recreation Center would be rolled back, putting Truman's increase in line with other institutions.

With the 2021-22 increase of 4.9% applied to 2020-21 charged amounts, the actual increase to full-time students would be \$390 for a Missouri undergraduate. Expressed as the cost per credit hour, the proposed increase is \$13 per credit hour for a Missouri undergraduate student. The total increase for a student living on-campus will be \$518 for the academic year. Actual costs for 2021-22 for undergraduate students are outlined in Table 4.

ITEM H.4 Food Service Contractor

DESCRIPTION AND BACKGROUND

Sodexo currently provides food service for the campus under a contract which expires in May 2022. Although several interested vendors visited campus during the last bid process, the only firms submitting a proposal other than Sodexo were relatively small and did not have any higher education operations comparable in scope to those at Truman.

During 2020-21, Truman officials have worked with Sodexo management to develop successful plans adapting the on-campus food service operations during COVID. Sodexo staff have dealt with numerous challenges involving social distancing, delivery of meals to quarantined students, and maintaining standards under dramatically different circumstances. The Sodexo team has responded very quickly during this crisis and has consistently provided quality food options for Truman students.

The typical food service contractor selection is a very lengthy multi-step process. It begins during the summer months with potential vendors visiting campus to review the dining facilities, the food court, and kitchens. The bid documents outline recent enrollment trends, occupancy rates in residence halls, and current food plan options including costs. During previous bid evaluation processes teams of staff and students have visited other campuses during the fall semester to review operations of bidders. A final decision regarding the contract is typically made by the start of the spring semester.

Given the impact of the COVID pandemic in 2020-21 and uncertainty regarding resumption of more normal or typical food service options, it would be difficult for competitors to evaluate the food service operation at Truman. Similarly, it may be difficult for an evaluation committee to visit other campuses in fall 2021 or evaluate quality of service elsewhere. An additional factor is the current lower occupancy levels in residence halls and the number of students utilizing food plans, which would impact the proposals from bidders.

The Sodexo team at Truman has done an excellent job serving campus during the pandemic and it is recommended that the current contract be extended for two additional years, with a new end date of May, 2024. This would allow time to rebuild occupancy in residence halls, and initiate a comprehensive contractor evaluation process via an RFP which would begin during the summer of 2023.

RECOMMENDED ACTION

WHEREAS, the current contract with Sodexo Food Services ends on May 15, 2022; and

WHEREAS, it is advisable to extend this contract for two additional years, with the stipulation that the contract will be competitively bid at the conclusion of this period; NOW, THEREFORE, BE IT RESOLVED that the President of the University is hereby authorized to negotiate an extension to the current Sodexo Food Services contract; and

BE IT FURTHER RESOLVED that the President of the University, or her designee, be authorized to sign a contract with Sodexo Food Services for a two-year period beginning May, 2022, and ending May, 2024.

Education & General (*Pages A1-A3*)

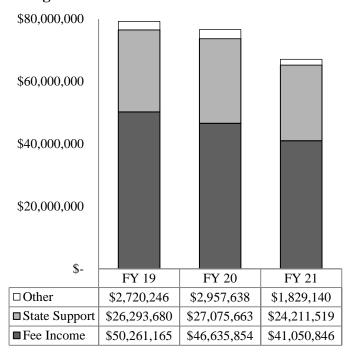

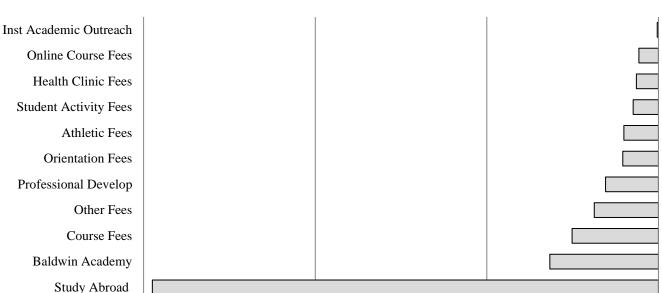
Figure 1: Education & General Revenues

Revenues fell by \$9.6M (12.5%) to \$67.1M primarily due to a \$5.2M tuition shortfall. The revenue distribution over the last three fiscal years is outlined in Figure 1. After eight months, overall revenues were 78.5% of the fiscal 2021 budget.

Tuition increased by 2.3%, but this rate increase was offset by 576 and 554 fewer students enrolled for the fall and spring semesters, respectively.

State revenue fell by \$2.9M (10.6%) to \$24.2M due to withheld appropriation. The State of Missouri withheld \$5M of appropriation in the prior fiscal year. However, as the State of Missouri recently restored a total of \$1.5M of unrestricted appropriation in October and January, the current variance will continue to narrow. Assuming no further changes, the

University is projecting a \$36.8M annual unrestricted appropriation for fiscal year 2021 (\$1.5M greater than prior year, but \$3.5M less than the original 2020 appropriation). On a restricted basis, the State of Missouri recently released an additional \$3.7M in maintenance and repair funding as well.

Other revenue decreased by \$1.1M (38.2%) to \$1.8M based on an \$854,701 reduction in interest income on investments, a \$269,310 decrease in student health related income and a \$52,621 drop in camp-related fees. In addition, course and other fees fell by \$406,321 (9.6%) to \$3.8M. The year-over-year variances in local fee revenue (excluding tuition) are outlined in Figure 2 below.

Education and general expenses fell by \$6.2M (9.6%) to \$58.4M based on total compensation reductions of \$2.4M (6.7%) primarily due to 31 fewer faculty and staff positions and \$207,174 in COVID-related grant funding. Faculty and staff salary savings of \$1.5M (6.4%) were partially offset by a 1.8% average wage increase that took effect in January 2020. Corresponding fringe benefits decreased by \$555,362 (5.9%) to \$8.9M, and student employment also fell by \$308,870 (13.6%).

Expenses over the last three fiscal years are outlined in Figure 3. After eight months, expenses were 64.21% of the fiscal 2021 budget. Notable expense variances included:

- Institutional aid decreased by \$1.7M (9.0%) due to the loss of 171 freshmen.
- Travel fell by \$1M (86.7%) due to pandemic restrictions.
- Professional services fell \$353.609
- Other expenses were down \$246,110 (32.9%) primarily due to fleet fuel and repair savings.
- Equipment and capital costs decreased by \$234,193 (38.9%). Current year projects were offset by non-recurring prior year costs including the planetarium (\$144,500), the Pershing Arena video board (\$118,000) and the natatorium pool liner (\$100,000).
- Library acquisitions decreased by \$105,850 due to reductions in certain academic subscriptions.
- Utilities fell \$66,462 (4.8%) due to the summer campus closure, shuttering the Kirk building and efficiency gains from recent chiller replacements.
- Office contracts increased by \$83,683 (8.0%) based on software license renewals including Cisco (\$28,463), Funnelback Search Engine (\$15,272) and Ellucian ERP (\$13,841).

Auxiliary Systems (*Pages B1-B3*)

Auxiliary revenues fell by \$4.5M (21.1%) to \$16.7M primarily due to a \$4.1M (21.9%) shortfall in residence hall income. variance was caused by non-existent summer residency, and the reduction of 360 and 390 student residents for the fall and spring semesters, respectively.

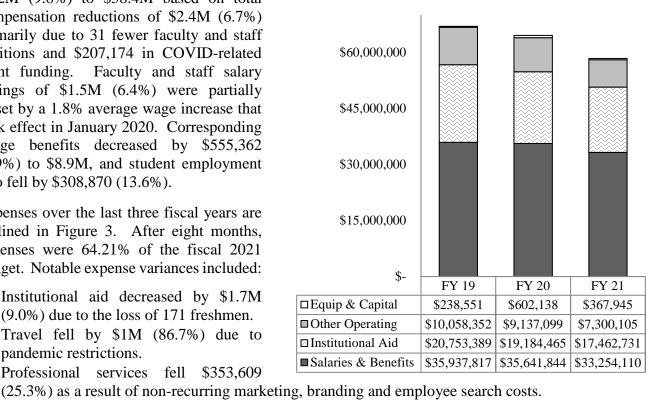
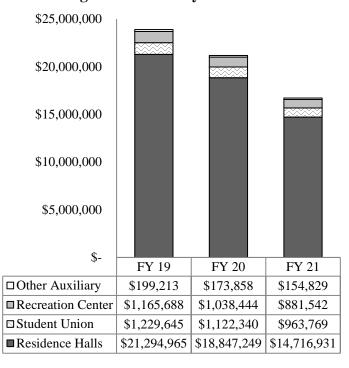


Figure 4: Auxiliary Revenues

The revenue distribution for the last three fiscal years is outlined in Figure 4. After eight months, revenues were 82.7% of the fiscal 2021 budget.

Figure 3: Education & General Expenses

Reduced enrollment also negatively impacted Student Union and Recreation Center revenues by \$158,571 and \$156,902, respectively. Finally, other auxiliary revenue fell by \$19,029 due primarily to reduced printing income.

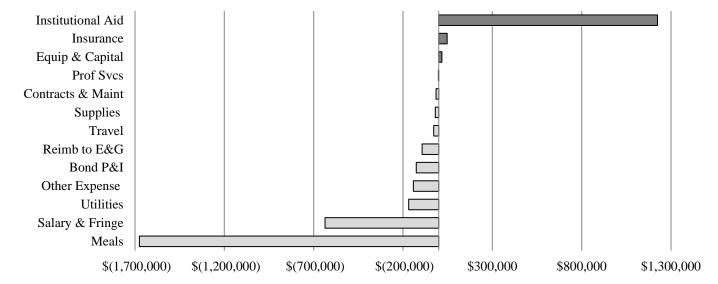


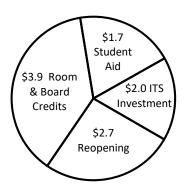
Figure 5: Auxiliary Expense Variances (FY 20 to FY 21)

Auxiliary expenses decreased by \$1.6M (11.9%) to \$12M primarily due to a \$1.7M decrease in overall meal costs. After eight months, current expenses were 57.2% of the fiscal 2021 budget. Other notable expense variances are outlined in Figure 5:

- Institutional aid increased by \$1.2M due to a new Housing Support Scholarship offered to 698 freshman students. This \$2,000 scholarship was offered for one year only, and it was designed to stabilize residence hall occupancy. Occupancy was 52% and 50% of designed capacity for the fall and spring terms, respectively.
- Compensation and benefits decreased by \$636,309 (20.9%) to \$2.4M based on 8 fewer staff, reduced student employment and \$91,479 in CARES Act reimbursements for COVID-related leave.
- Utilities expense fell by \$168,131 (15.3%) due to reduced residence hall occupancy.
- Bond principal and interest payments were reduced by \$125,757 (17.4%) as a result of refunding 2013 series of housing revenue bonds with a new 2020 issue.
- Other expenses fell by \$115,817 (27.9%) due mainly to discontinuing cable television service in the residence halls.

COVID-19 Related Grant Funding

Through the end of February, the University received \$10M in Coronavirus Aid, Relief, and Economic Security (CARES) Act funding. Grants were administered though the federal Higher Education Emergency Relief Fund and through the Coronavirus Relief Fund managed by the State of Missouri and Adair County. Fund allocations by major category are illustrated in Figure 6.

The most important use of funds consisted of student emergency financial aid grants. The University was able to distribute \$1.7M to 2,100 students for food, housing, health care and technology needs.

Additional funds offset \$3.9M in room and board credits that the University issued to students following the closure of the residence halls during the prior spring semester.

The University received \$2M to upgrade its information technology infrastructure to improve remote instruction capabilities for students and faculty.

Finally, the University received \$2.7M for various re-opening expenses including converting existing facilities into socially distanced classrooms, compensation support to repurpose faculty and staff in response to the pandemic, purchasing emergency cleaning supplies and personal protective equipment, and facilitating the COVID testing of students.

It is important to note that only \$1.1M of the COVID-19 related grant funds received were reflected as expense reimbursements in the Education & General and Auxiliary current funds reported above. The majority of the reimbursements were (1) applied to prior year costs, (2) applied to plant expenditures for capitalized ITS infrastructure upgrades or (3) represent a pass through of funds in the case of emergency financial aid payments to students.

With the recent passage of the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) on December 27, 2020, the University was allocated an additional \$1.7M in emergency aid designated for students with the greatest financial need and an additional \$3.4M for institutional costs.

Truman State University Foundation (*Pages C1-C3*)

Statement of Net Position (Page C-1)

Fiscal year-to-date net position improved by \$12.3M to \$70.4M. Current assets grew by \$426,893 based on a corresponding \$610,234 increase in short-term investments. The growth in short-term investments was primarily due to a \$500,000 July contribution from the Sunderland Foundation for improvements to the Greenwood Autism Center. There were also smaller increases to Men's Basketball Purple Pack fund and the Bulldog General fund. More notably, non-current assets increased by \$11.9M to \$64.5M based on a corresponding \$12M increase in long-term investments (due largely to the appreciation of the equity market). Current liabilities decreased by \$14,352 to \$108,097 due to a corresponding \$18,062 decrease in accounts payable. Long-term liabilities were comprised wholly of annuities and trusts payable of \$473,029 (\$31,237 less than prior year).

Statement of Revenues, Expenditures and Changes in Net Position (Page C-2)

Contributions and additions to the permanent endowment fell \$580,861 to \$1.9M. A portion of this unfavorable variance was due to large prior year gifts to the Greenwood Renovation fund and the Kerby Family Business Excellence fund that were not repeated in the current year. However, investment gains increased by \$9.3M to \$10.1M. Expenses and transfers totaled \$2M this year compared to \$3.5M during the prior year. The variance was primarily due to the \$1M prior year transfer to Truman State University for the Sandra K. Giachino-Reavey Sesquicentennial Plaza. Scholarship expenses also fell by \$431,326 in the current fiscal year.

Investments Schedule (Page C-3)

Investments (including endowed, short-term, long-term, trusts and annuities) increased by \$12.6M to \$69.7M with the majority of the growth (\$11.8M) concentrated in the endowed pool. The Foundation also holds beneficial interests in three separate trusts. Their value increased \$422,115 to \$4.2M.
