





BOEING SUPPORT

The School of Business was awarded an expanded grant from The Boeing Company for the 2022-2023 school year. While this grant supported student and faculty development, student scholarships, and the launch of the Tru-Leaders Next Gen program (see article), a large portion of the grant allowed Truman State University to obtain a **Bloomberg Terminal.**

Truman's Bloomberg Terminal is hosted in Violette Hall 1400. This

room is available for classroom demonstration, student use, and student organization use. Students have access to real-time financial data, company research, news, and analytics.

When asked about his experience with the Terminal, senior Ryan Hake shared, "The Bloomberg Terminal has been a great asset to me in both academic and professional life. I've only used the Terminal for a minor amount of coursework so far. Most of my experience has been using the Terminal for my school organizations and my internships."

Additional Support

ALUMNI SUPPORT

With the support of funds established by Chuck and Sherri Woods, Susan Hatcher, Mark Barner, the Kerby family, and the Romine Family, the School of Business was able to purchase five laptops for student check out. Over the course of the academic year, these laptops were checked out by 18 students and used for 248 days. Several students borrowed laptops to bridge the gap between school starting and their new laptop arriving. Others checked out the laptops because their personal computers would not run software being used in the class like Alteryx and Tableau. Finally, in several instances the laptops were helpful in emergency situations when a student's personal laptop unexpectedly broke. The School is grateful to be able to provide this resource to students.

GRANT SUPPORT

Truman was the recipient of a MO Excels grant. While this grant supported faculty development in technology and the development of BSAD 153 as an online class in the School of Business, it also allowed for a Data Analytics lab in Violette Hall 1420. With the grant, the School was able to purchase 32 computers that can run software like Tableau, Alteryx, IDEA, and PowerBI. The computers are also able to handle larger datasets in Excel.


BRIDGE CEREMONY

The certificate requires four courses in foundational business analytics knowledge and skills, two courses in core business analytics knowledge and skills, and one elective course in application of business analytics knowledge and skills.




Alumni Fellows Recipient Honored

BULLDOG STUDENT INVESTMENT FUND

The Bulldog Student Investment Fund (BSIF) is a small group of students who have a passion to learn and implement Private Equity and Investment Research. BSIF is comprised of 32 undergraduate students who have gone through multiple challenges to obtain admittance into the Fund as well as gone through equity valuation classes. Currently, BSIF manages \$172,000 of capital with \$121,000 of that being in equity. Members pitch equity investments to the fund through qualitative and quantitative research where the fund then votes on whether to purchase stock or not.

BSIF was awarded the 2021 Outstanding Small Organization Award from the Center for Student Involvement. In this past semester, BSIF was able to compete in the Global Asset Management Education Forum (GAME) in New York City, where they placed 2nd place among Small Cap Student Investment Funds. These eight members represented Truman State University amongst thousands of students from around the country as well as leaders in all different aspects of the financial field. BSIF is grateful for generous support from alumni and donors who have made investing, travel, and competitions possible.



BETA ALPHA PSI

The Kappa Nu chapter of Beta Alpha Psi provides members countless opportunities to develop their professional and interpersonal skills. Mitchell Kronsbein, a senior business administration major, finished third and won \$1,000 for his pitch for Fur Hearts, a premium pet food business that directs a significant portion of its revenue to support animal shelters.

Grace Johler, senior communications major, and Esther Lee, senior business marketing major won the 2022 Bulldog B.I.T.E. pitch competition. Their pitch for a non-profit to support local

immigrant-owned businesses won them the Amanda Gioia Excellence in Entrepreneurship Award and



earned a prize of \$3,000. Kaleb Fothergill and Lola Ellison, Moberly Area Community College students, received \$2,000 for their pitch of a pot and pan safety device to help prevent kitchen fires. He also expressed his appreciation for his students, stating that he "couldn't be happier to follow up one fun and exciting work career with another and to work with so many talented and fun students."



funding for results. She was also heavily involved in curriculum development, serving as the Chair of the Commission Curriculum Reform (2006-2009), a member of the Next Steps Team 8 Implementation Committee (20016-2017), and a member of the LSP Proposal Review Committee. Once the revised LSP Proposal was adopted, she served as the Chair of the Self & Society Implementation Committee (2018-2020). They finalized the requirements of the Seminar,

Outside of the University, she represented Truman State on a three state, fifteen campus Task Force established to "tune" the marketing curriculum by establishing a common agreement on what marketing students need to know and be able to do upon graduation. Her other major area of involvement was in advising student organizations. Alumnus Spotlight - Changing Lives



At his 40th high school class reunion, like many, Ken Rickli got the chance to reconnect with some old friends. They discovered a shared interest in old cars and, for the nearly the next decade, met annually to attend the Barret-Jackson collector car auction in Arizona. During one trip, a friend of Ken's explained that he and his wife created a scholarship for students from Affton High School. Ken thought he would like to do the same, so in 2011, he and his wife Kathy established the Rickli Family Scholarship, which has provided 4-year tuition free assistance at Truman State University to one Affton High School graduate every year since 2012.

In 1939, Ken's Swiss immigrant parents and older brother moved from New York City to the Midwest and bought a home with a double lot just south of St. Louis, in Affton. Ken was born the next summer and was raised in the Rickli family home, just blocks from the Junior-Senior High School. "It was a great place to grow up. Especially with all the neighborhood kids." Rickli said. When he established the scholarship, Ken wanted to recognize more than just the graduates from that area, so the award also honors Miss Doris Ahrens, Ken's high school English teacher. "Miss Doris Ahrens was a special teacher. She could explain any question you had, and you would understand her explanation. There was no doubt that she wanted all of us to succeed."

Ken's summers were spent working to earn money for college and he always had camp as part of his US Marine Corps Reserve commitment. The summer after his sophomore year, he fractured his right arm and could not continue school. After recovering, he went right back to work. Ken had many high school friends attending Northeast Missouri State Teachers College at the time and they convinced him to transfer and finish his business degree in Kirksville. "It was the best decision I made in my short life on this planet!"

In the fall of 1965, the new graduate took his first job with a large Houston, Texas corporation, Texas Eastern Transmission Inc., as a Financial Analyst in the natural gas industry. He was only with the company for about nine months, but his last week of work just happened to be the first week of work for a lovely young woman named Kathy. Ken moved to an inside sales position with a small electronics company, E&M Instrument Co. A year later, they offered him an outside sales position, his dream job, and he and Kathy were married on July 29, 1967.

Ken enjoyed his sales work, but a school friend lured him back

to Houston to run his business - taking total loss vehicles from insurance companies and selling them through bids. Starting in March 1971, Ken mostly managed the recruitment and retention of their customers. Over time, they became the largest salvage auction in Texas. The business was sold in January of 1994. At that time, another close friend and customer convinced him to partner and open their own salvage auction. That business opened in September of 1994 and in 2001 and 2005, expanded to two other Texas locations. They sold the operating arm of the business in late 2006. Estimated total sales in 2006 were 65,000+ vehicles.

In their retirement, Ken and Kathy have enjoyed getting to know their scholarship recipients. One graduated from Truman and is now completing two master's degrees. Another finished her bachelor's degree in three years and is using her fourth to get her master's at Truman. A very special one came from a difficult situation and told them Truman felt like her new home. All the students have expressed genuine gratitude for the scholarship and the Ricklis are pleased they are making the most of the assistance. "It has been a very rewarding experience for us. To know you are helping someone you do not know, but deserves to go to college, is as highly rewarding."
